This year's list features a different methodology than the previous year's Private Companies lists. In order to appear on the list, companies must provide audited financial statements, which were then verified by an outside CPA firm, Young, Craig + Co. LLP. Because of the change in methodology, some companies featured in previous years were unable to participate.

In addition, some companies appear on the list because they have submitted audited financial statements to the Securities and Exchange Commission and filed to go public, but were still privately held at press time.

Corsair Components Inc., ranked No. 5 with \$455.2 million, filed for IPO in April 2012, and subsequently withdrew its IPO in May 2012.

Silver Spring Networks, ranked No. 8 with \$237.1 million, filed in July 2011.

Cortina Systems Inc., ranked No. 18 with \$141.1 million, filed in March 2011.

Ambarella Inc., ranked No. 24 with \$94.7 million, filed in

Qualys Inc., ranked No. 26 with \$76.2 million, filed for IPO in June 2012.

GCT Semiconductor Inc., ranked No. 27 with \$68.6 million, filed in September 2011. It postponed its IPO in March 2012.


